SUBJECT: Fresh Air Campus – Smoking Policy

Background Per Idaho Code 39-5502, smoking is not allowed inside any college owned property or outside within 20-feet of all entrances/exits. LCSC policy is more restrictive than Idaho Code. Smoking is not allowed on any College property, indoors or outdoors, except in specifically designated outside areas, as described below.

SUBJECT: FRESH AIR CAMPUS – SMOKING POLICY

1. Policy Statement

Lewis-Clark State College (LCSC) has been designated as a non-smoking, “fresh air” campus. In accordance with Idaho Code, Title 39, Chapter 5500 Clean Indoor Air and <http://adminrules.idaho.gov/rules/current/16/160223.pdf> LCSC has adopted the following non-smoking policy.

1. “Smoking” includes the possession of any lighted tobacco product in any form, as state by Idaho Code. As further clarification, LCSC considers use of bidis, kreteks, e-cigarettes, pipes, cigars and hookahs as smoking.
2. Smoking is not allowed inside or within 20 feet of an entrance or exit of any College-owned, leased, or operated building, including but not limited to the Music Building, Pi’amkinwaas, North Lewiston Training Center, the Center for Arts and History, Adult Education Center, and Outreach Centers.
3. Smoking is allowed in five designated, peripheral parking lots located on 4th Street, 11th Avenue and 6th Street. See link to [map](#) for clarification.

4. Persons (defined as students, staff, contractors, volunteers, or visitors) found to be in violation of the smoking policy are subject to a fine not to exceed fifty dollars (\$50.00). Violators may be asked to immediately stop smoking and/or leave the premises. Violations may be reported directly to local law enforcement and could result in the violator being banned or trespassed from campus. Students and staff may be subject to disciplinary procedures.

5. When using North Idaho College or University of Idaho campuses in Coeur d'Alene, students and staff will comply with the host institution policy and may be subject to LCSC policy.
